 - Just getting ready for my ASO meeting next week.
- Guest Speakers
 - Karen Johnson and Mick Lynch-Mental Health First Aid
 - We want to talk a little bit about Mental Health First Aid. Everyone of you as a student leader could benefit from first aid training.

- Mental health first aid teaches risk factors and how we can help them and connect them to the resources they need. It not only teaches you how to intervene in a crisis but you can help anyone with any crisis. I envision this campus being more mental health friendly. Be the difference. I think all of us here can embrace that tonight if you consider what we ask for you to hear.
- What we are asking about may be a bit of an ask. 1 in 25 people struggle with a mental health first aid crisis. Having those skills can be extremely beneficial. Being able to diagnose and direct them to where they might need. It is important to take care of our mental health. This is us putting our money where our mouth is and taking action
- The cost first hand was \$200. Mick is willing to teach the class of \$25 per person
- Mick: There is a cost that goes towards this. The \$25 is towards materials and a book. If student senate would purchase 30 seats for 30 interested students and then we can continue our talks on how to keep it sustainable. Anyone who does 2 hours of pre-work online does the 6 hours in person. The total ask would be \$750
 - Senator Haugen: Do you foresee the price changing over time? If we buy 30 seats now, if someone wanted to buy 60 would the price change?
 - We do not know. We don't control the prices. We would check with them
 - Senator Howarth: I think this is an amazing idea. Say we do fund for the 30 max seats, would you or the university want to collaborate with the university or the green bandana project, if we have people who are interested. If you get the max of 30, what would you be looking towards?
 - Mick: We work collaborating with all mental health and green bandana to open it up to everyone we can. There are only thirty seats. Academic and athletic.
 - Dean Johnson: I'd like to train as many students as we can. Mick doesn't get paid for this
 - Senator Peil: What are the chances to get something like this a credit class?
 - Mick: That is a long process. There are classes HERS 250 & 252 taught by Connie. It is not very likely that we would get to the point of giving college credit for this class.
 - Senator Carman: I love hearing about this. Do other universities around us offer this training?
 - I'm not sure if they offer the formal class. I know all universities in our system have trainers.
 - Senator Kurth: I think this is great. You mentioned you were tentative on making this sustainable. Would you come back every year for funding?
 - Johnson: not quite positive. The MN state legislature has been generous in giving us funding. If we can depend on our legislature to keep giving us funding, hopefully.

- Mike: Thirty people a year is not many so we are hoping to open the training up to masses of students. If you have ways you known of to sustain this then we are all ears
- Senator Simon: Is a certificate they could put on an application for a job?
 - Yes. You can not get the certificate unless you go through the class. You do get one and I suggest you print it out
- Senator Simon: Is there a lifetime certification?
 - Every three years. And I believe there is a online renewal
- Senator Carman: What is the normal cost without the discount?
 - \$18.95 annual training and \$23.95 for six hour training. Offering it to community members is more expensive
- Senator Carman: How much are you asking?
 - \$25 per person for 30 seats so \$750
- Senator Carman: I feel like putting it on a promotion that it can help your future job would help a lot of people be interested.
- Chair Bainbridge: Why can't those funds be this year from the legislature?
 - It is being used for basic needs, emergency funding, and training for employees for mental health. There wasn't a big amount of it.
- Chair Bainbridge: Does the dollar amount stay the same year that the legislature gives?
 - This is the first year so we hope that it will continue
- Senator Galvin: I think it is important that you have that voice and appreciate it. Is it an overall weekend course?
 - It all in one day
- Senator Peil: How reasonable would it be for \$25 per person to get as many students as we want? Would it be reasonable to increase student fees and use that?
 - I will not be the one to increase student fees. If anyone on that committee wants to propose it they can

Therefore be it further resolved, WSUSS recommends WSU places signage to existing sharps containers.

- Chair Hossain: This helps students who have diabetes. I can't take needles because I am diabetic and I don't know where to dispose of them. This is a recommendation to put out disposal containers around campus
- Senator Carman: This is a fantastic idea. I have been to other campuses and they have these. I think this would be very inclusive.
- Senator Abagat: I am a part of this committee but also a nursing student. This is so important to diabetic students and gender transitioning students with shots. This can also help other students who use injections. Injections are a way for them to get fast treatment and it would be nice for them to be readily available
- Senator Minich: I think that it's an amazing idea. In the cafeteria they post that please do not leave your needles on the trays because it can be harmful to employees so I think this is beneficial
- Senator Patterson: Are there any of these around campus?
 - President Carman: George and I are working on looking into that right now.
 - Chair Hossain: I haven't seen any.
 - Senator Haugen: East lake bathrooms have them. Most resident halls
- Senator Galvin: I have seen some in Minne, I think in the 2nd floor men's restroom. I haven't seen a whole lot around campus. I have seen some in St. Olaf campus in every bathroom they had. We have so many students so it is mind boggling that we don't have any. This should have been passed a long time ago. Should have been implemented when the college was almost founded.
- Senator Howarth: I am on the committee as well, so I think our committee did an amazing job writing this motion. For anyone who may not feel safe with disposing.

- Senator Kurth: I'm in support of this motion and it has been a thing that has been around for awhile. I'm surprised that it hasn't been around on campus that much. We talk a lot about helping mental health but for some reason we stop talking about physical disabilities. I think Winona State doesn't do a lot with accommodating those with physical disabilities. In the gym there are needle boxes in one of the boys bathrooms
- Senator Peil: This is all about access. If you have class somewhere and you have to leave to go to a different floor in the middle of class, this can help so students aren't late to class or miss class time. A lot of students do best focusing on their studies with their medical conditions
- Chair Bainbridge: friendly amendment: where they do not already exist
- Senator Moran: I think this is a wonderful idea. I would want to maybe suggest a friendly amendment for signage for students to know where they exist. If someone wants to make that amendment. Friendly amendment: Therefore be it further resolved, WSUSS recommends WSU places signage to existing sharps containers.
- Senator Patterson: For some people this may be life and death. If they don't have a place to dispose of this, I'd feel crappy. I can't imagine that someone is going to want to take a needle out in the middle of class or running across campus to dispose of it

• Committee recommendation passes

■ *Whereas*, diversity and inclusion are important to WSU,

Whereas, having a medical room would be beneficial for Winona State University faculty, students and community members,

Whereas, medical room provides privacy and a safe space for those afflicted with medical condition,

Whereas, public bathrooms contain thousands of germs that make it unsafe to do medical routines,

Whereas, providing a medical room is addressing public health safety for Winona State University community,

Therefore, be it resolved, WSUSS recommends that WSU provide all proper resources legally required for a medical room.

Therefore, be it further resolved, WSUSS recommends that WSU place a minimum of one medical room in all academic buildings.

Moved by: Equity, Inclusion and Excellence Committee

- Chair Hossain: This motion highlights benefits. This would help in sanitary and privacy. I believe that one medical room in each academic building can help. When we have this room, we would suggest that any resources are kept in the room in case of emergency.
- Senator Carman: My only concern is where is the money going to come from? If this was in Kryzsko would this come out of their budget? Where would the money come from for these resources?
 - Chair Hossain: We have a meditation room and prayer room. If we have a spare room in a building, I believe we can use those. We can work with the health services on campus for resources.
 - George Micalone: Space management on campus is kind of a cluster. An idea like this would take a lot of time. The finances to prioritize that would take a lot to plan for. To prioritize money for this would need for you to raise a lot of noise.
 - Chair Hossain: I believe heath services have a room already. I will talk to the director of health and services. I believe this is necessary and we can find a way.
 - Senator Moran: friendly amendment: change medical attention to medical condition
 - Chair Bainbridge: As someone who has been fighting this campus, it is difficult to work with people. They only have so much money. I think you need data. Whether you put out a survey or talk to students. Tell them this is what senate recommends. We have a lot of young senators, you can keep pushing this. I don't see it being something that changes soon. I think it is something that has a lot of potential and a big need for students
 - Senator Stoeckly: One of these rooms was actually implemented in my past high school. I think we need to still push for it after this semester so it doesn't get pushed under the back burner
 - Senator Patterson: Since we have limited funding, would there be a way for us to put those resources in gender neutral bathrooms?
 - The reason we wanted to have a room was because bathrooms are filthy.
 - Senator Patterson: Health services are only open a limited amount of hours too that isn't very accommodating to students
 - Senator Haugen: I am extending my energy and time to help you with this. I have in mind a few professors who would like to help with this. I would

like to talk to some people to swab the bathroom to show everyone what germs are in there. We can talk to our faculty members to start this

- Senator Peil: I would like to assume that students are here to make a difference in students' lives. Regardless of if this happens this semester or years to come. This will impact hundreds if not thousands of students to make it more accessible. This can increase student positivity and increase enrollment
- Senator Carman: I think we all agree this needs to happen so let's start with getting data. I would like to table this motion
 - Seconded by Senator Haugen

 - Senator Patterson: Can I suggest emailing the EIE Keap Center. It is a great resource that no one really knows about.



- Senator Peil: Obviously \$10,000 is a lot of money. I wonder how sustainable it is to pass this motion and all the other motions tonight. I don't think the full amount is possible but I would like to fund a large portion
- Chair Bainbridge: I do think International Night is a good event. They do already get some funding \$4,600 from the student life fee that they could put towards the event
- Senator Haugen: I think no one is against this motion. They do receive \$4,600 which is more than any other club. I propose that we take off \$2300 from the total they asked for. It is not because I do not believe in this. I think it is fair that they use half of their money to put towards this event
- Senator Peil: amendment instead of the current change that to \$8,427.54
 - Chair Hossain: To use half the money for our club at this point is not possible. We already set up our entire plan. If you ask us to take it out of our current

budget we won't be able to do it. We are funding similar to the warrior entertainment network. I don't see any reason why this is being lowered. It is for the community and for the people. I do not think this amount should get any lower. The plan has already been made

- Chair Bainbridge: This will be a tough conversation because we all love the International Club. We had conversations that students and clubs can't always expect senate to fund their requests. I wish International Club can do everything they can. I think we should hold this to the same standard that senate can't always fund everything
- Senator DeLuca: I agree with a previous chair that they can't expect to get all the funding. I do believe that International Club isn't allowed to fundraise so this should be an exception. Just because it is a big number doesn't mean it is the least important
- Senator Haugen: This isn't about saving money. This is about establishing that senate isn't always going to fund everything. However if students find out that a club gets \$4600 a year. They are using it to go on trips, they said Wisconsin Dells. I feel like funding would disrespect students on campus. I already have students talking to me about this. This is a fair ask. At risk of being the bad guy, I feel like the expectation was already there that we were going to fund this. I think it is fair for senate to establish that clubs shouldn't expect funding. This is coming down to an accountability issue. I feel senate has an accountability issue. What is wrong with having a club held accountable with their lack of planning that senate will fund the entire amount. I always have a plan a b and c. I'm a broke college student. I am not trying to attack anyone in this room
- Senator Carman: I think something we also need to take in consideration, it is January. We still have tons of clubs that will need to go to events to promote networking and further their career. Other clubs will be coming in here asking for large amounts of money. I agree with accountability. It is only January. That is something we need to consider with future clubs coming to us
- Senator Peil: This is no one's fault. Chartwells just happens to be very expensive when catering. I think we also have a conflict of interest because we have a president of the International Club here. It is tough that we have this advantage to know where the money is planned and where it is going. Not every club has that advantage to come in a second time to tell us where the money is going.
- Senator Kurth: I feel like I'm pretty conflicted about this. I want to give International Club all their money. How is this club funded compared to every other club?
 - Treasurer O'Connor: Student life fee. There are 40 groups that get that funding. ONe of them is the International club and that is \$4600. They get that money while those other groups have to request it.
- Senator Kurth: Just to build on that I feel that this is also a problem that goes on outside of International Night. The reason they were funded is for this event. If it was designated for an event to go towards students it would be a disservice for


the club members to go on a trip. But it would also be a disservice to not allow them not to use the money for other stuff for their club.

- Treasurer O'Connor: clear up something. Tracy told me the reason they were given the \$4600 was given for International Night because they asked so often. However, they can use it anyway they want
- Chair Bainbridge: We are not canceling International Night. Maybe some of the posters will be cut or some of the drinks. We can't tell them how to spend their money. It is not canceling the event, it is having the club adjust it. Last year meeting minutes they said they were going on a trip and international night. We did not fund all of it and they still had the event and still went on the trip. They would just have to adjust some of the things they would like
- Senator Crowe: \$10,000 is a lot of money. Looking at their ticket sales, if they take \$1,000 from their ticket sales they can still put on this event
- Senator McLaughlin: When it comes down to almost \$11,000, it is a lot of money. Other clubs also have a say
- Chair Hossain: To clarify concerns: we can ask groups for clarification. We can also call back groups with advisors because we have done it in the past. We did send emails to clear up any confusion. If you go back to the presentation of the International Club, I see that the food cost is \$8,988.66.
- Senator Peil: Do you look at digital signage more than paper signage? Head nods*. As great as all the promotion is, there may be more ways for them to promote this that are cheaper.
- Senator Crowe: Looking at the clarifying document. It says \$500 scholarships. Where is the rest of that money going?
 - President Carman: As far as I know, no scholarship has gone out
 - Senator Serchan: This is the first year the club is doing the scholarship.
- \circ $\,$ Senator Carman: I would like to make amendment to the amendment $\$8,\!988.67$
 - Seconded by Chair Bainbridge
- Senator Carman: Let's at least fund their food costs because they cannot control the price and adjust it.
- Chair Bainbridge: I think this is a fair amount to cover their food
 - President Carman: Chartwells does have their amount. But the cost can get cut because of the portions and the type of food they asked for.
- $\circ \quad \text{Discussion on amendment to amendment}$
 - Senator Haugen: For someone who has to abstain from a vote they have to have a big part in the vote?
 - President Carman: yes
 - Senator Haugen: In there original presentation it would have been nice to know that their money from last year would be used for this year scholarships
 - Senator Serchan: The people who presented last year are very new. Since Chair Hossain and I are on senate we are not allowed to present. So we have a short amount of time to get them ready. Putting planning in, puts in a lot of effort. Who is benefiting from International Night? The

International students and it would be nice for people to see that this event also goes towards scholarship. WSU is a predominantly white campus. Students who are domestic but have not had their roots outside the USA. I am not getting paid for this position. If this is funded it benefits the campus as a whole.

- Senator Peil: Oftentimes any club asks for money to fund a trip. Usually they have their club money and have the opportunity to fund raise which the International Club does not have. We fund the activity they are doing. Because to our knowledge they have money in their account, they would be able to afford the other means they are requesting for this event. I agree with the current amount. It is a fair ask.
- Senator Galvin: Call to question
 - Seconded by call to question Senator Carman
 - Call to question passes on amendment to amendment
 - Amendment to the amendment passes \$10,727.54 \$8,988.67
 - Senator Haugen: this new number reflects more fairly. This is us allowing them to put on their event with the expectation that college students will always find a way.
 - Senator Minich: the \$4,600 what is happening with that money, has any of the money been spent
 - Treasurer O'Connor: We do know that they have planned trip and do have several events planned for the current academic year
 - Senator Minich: Has the \$4600 been spent?
 - Chair Hossain: yes
 - Senator Minich: Student life fee is for student opportunities on campus. Important to note that I feel like the \$4600 went towards event and then asking for supplemental money and then coming back for requesting money for Wisconsin Dells
 - Senator Kurth: would like to call to question
 - Seconded by senator McLauglin
 - Call to question passes
 - Amendment passes \$8,988.67
