

Whereas, the minimum amount to get a recognized performer is \$20,000,

Therefore be it resolved, WSUSS allocates \$20,000 from the SAF to the Warrior Entertainment Network to book a noteworthy performer.

DISCUSSION ON MOTION

- Sen. Weber- did either of you reach out to them about the questions we were going to ask?
- Pres. M. Olson- overwhelming concern that was discussed was the lack of clarification as the speaker
- Sen. Weber- we are so specific of other clubs, almost down to the cent, from the senate standpoint we are proposing money without knowing what it is going towards, we should think about an amendment about having someone involved from senate

- Sen. Carman- big concern is other clubs that do not get nearly as much that did not get their full funding, this is a slap in the face in a way
- Chair Schiro- open to the dollar amount

NEW AMMENDMENT (Schiro, Peterson)

ADD: Therefore be it further resolved that Senate will be a co-sponsor of the event

DISCUSSION ON AMMENDMENT

Sen Sherchan- good point, we should get our same out if we funded it

Dir. Endreson- our name definitely needs to be on it

Sen. Wright- whart would co-sponsoring mean?

Chair Schiro- Other events that student senate has put funding into do not get recognition for the event

AMMENDMENT PASSES

DISCUSSION ON MOTION AS A WHOLE

- Sen. O'ConnorPeople are comparing this to other clubs, Warrior Entertainment Network has a great track record for university improvement, we cannot predict how much money we will have in the future
- Sen. Kurth- we should not spend the money "willy nilly", there should be some direction as to what the money is going to
- Pres. M. Olson- money does not go to next year, half of it does, this is not an annual request,
- Sen. Wright- last year, had a similar conversation last year to use money left over, seeing a repeat about extra funds, I don't think we should make this a repeat

NEW AMMENDMENT (Wright, Weber)

Therefore be it further resolved, one senator will be appointed to the planning committee for the Warrior

Entertainment Network Homecoming Event

DISCUSSION ON AMMENDMENT

- Pres. M. Olson- by all means, any senator could go to the meetings
- Treas. Rieken- if a senator does go to the meetings, what would they be participating in?

- Sen. Wright- the Network amended bylaws so the voting is different, you have to meet certain requirements in order to vote, that senator might have to meet voting requirements
- Sen. Weber- this doesn't neceaarily need to be someone who can vote, just an open line of communication
- Treas. Rieken- I think we should get someone to do this before we approve it
- Chair Jones- with the drag show, we usually have a good amount of say, I don't know how much we could do with the voting rules and Network's procedures
- Chair Schiro- We are thinking a little too much into this, as long as we got recognition and the logo on the posters

VOTE ON AMMENDMENT FAILS

Chair Jones- This situation would benefit a bunch of students, I understand we do not know what we are paying for, we have to accept mistakes we have made and do better continuing in the future Sen. Westcott- although we can't compare this to last year, it feels very similar

NEW AMMENDMENT (Sen. Minich, Sen. Carman)

20,000 to 10,000

DISCUSSION ON AMMENDMENT

- Sen. O'Connor- half of it would go to reserves anyway, this would help students
- Sen. Westcott- rather support this amendment than the latter
- Sen. Eichele- would support this, the network is reputable, but a lot of us are at a sticker shock,
- Chair Carman- we will not get anyone notable for 10,000. This is a really good step to have a good starter event for senate and Warrior Entertainment Network
- Sen. Hermerding- agree we would not get anything for 10,000. This is coming back to winona state, this is one of the biggest events of the year,
- Sen. O'Connor- comparing for normal clubs
- Sen. Carman- gives them the chance to redo their budget if we give them \$10,000
- Sen. Minich- do we need a noteworthy person to come? We need to set a precedent

- Sen. Wright- keep in mind we are talking about winona state students for clubs, this would be a community event, homecoming is a big event, it includes the community
- Chair Carman- they are already working from their reserves, we certainly don't want less events, we should show our support for bigger events especially for homecoming week and freshman, also to get our name out there
- George- we never take a first ask, get a \$30,000 performer for \$20,000, major market pricing
