 - o Recommendation for safety- locking classroom doors 24/7
 - Up to faculty member how they want to proceed
 - Ideas to get card readers for classrooms
 - Culture shift for campus- generally open campus
 - Concern for hallway congestion
 - Sen. Carman- What about ID access to general building?
 - Chris- this was discussed, there is reluctance with this for having enough exterior doors equipped for this, project in the works for this, doors are already equipped to be locked here
 - Chair Jones- do we have a threat response on campus
 - Chris- yes, some buildings are not yet equipped, but we do have an app for this called
 WSU security
 - Sen. Wright- I have concern, if aggressor knows locking plans, they could leave early and formulate a plan around this?

- o Dir. Johnson-are there policies that we have to be an open campus as a state school?
- Chris- no, institutions have open environment, but has risk. Look for ways to mitigate safety, no policies in place
- Chris- meeting with faculty senate, wanted to know how students felt about it, certain majors have rooms that are left open to study
- o Dir. Johnson- how many would you need for exterior door card readers?
- o Chris- 19
- o Dir. Johnson- and interior doors?
- o Chris- in the works, not a certain number yet
- Sen. Weber- A thought is a non-faculty member, they may need keys
- Sen. Carman- active shooter training for all students?
- o Chris- usually offer in the spring, we need to adjust how we do it
- o Dir. Johnson- a point about S2I, after hour study groups
- Chair Jones- walls in Helble are a see through material, is there anything we can do about safety in there?
- Chris- We can work on the facilities manager to explore that
- Sen. Peterson- please keep clubs in mind
- Sen. Wescott- bringing in active shooter as an orientation mandatory training for freshman?
- Chris- timing is important in that, we can find some time to do that and a location
- Sen. Wescott- I thought it was the most useful training
- Chris- other universities offer it as an option
- Chair Schiro- maybe have all of ed village locked? As they are the farthest away from campus security
- Dir. Johnson- do you have safety say about Cecil or are they any recommendations you have made?
- o Chris- yes, they are discussing more about access
- o Dir. Johnson- will there be higher employment to manage higher security?
- Chris- we are getting closer to be able to do that, working with IT to automate how we
 request form, right now we have a carbon copy for keys, looking to create a form for ID
 access, like a warriorspace form
- Director Johnson- would there be a way that southeast tech students could use our resources?

- Chris- it would be more about staff and faculty, and we have southeast tech students in mind with this
- Sen. Minich- Any other options besides key entry? Like metal detectors
- Chris- all comes down to staffing and finances, would need licensed or armed people,
 would be difficult to apply here
- Sen. Hermerding- I have security saved in my phone, we could make sure to give security's number to clubs for this to happen.
- Sen. Hermerding- have you talked ot legislatures about this directly?
- o Chris- in short, no
- o Sen. Weber- would be worth talking to GMWs about this and gaining their insight
- Chris- we'll continue to keep them in the loop
- Sen. Houssain- how do you think we can manage that with Admissions coming in?
- Chris- working with WSU Ambassadors for further insight
- Treas. Rieken- I would rather be not practical, is there anything senate can do tho help the situation?
- Chris- be supportive of it, start taking stats, follow recommendations

NEW COMMITTEE RECOMMENDATION

Whereas, menstrual equity is important to the students at Winona State University,

Whereas, WSU students deserve access to menstrual products,

Whereas, there are limited stores in walking distance to buy menstrual products at an affordable price,

Whereas, gender neutral bathrooms are the most equitable space for those who menstruate to receive the products,

Whereas, the Student Union has agreed to keep menstrual products stocked in all five gender- neutral bathrooms of Kryzsko Commons,

Whereas, Aunt Flow's dispensers allow for more accessible use of the dispensers compared to the current ones,

Whereas, cartridge pads cost \$125.00 for the initial stock,

Whereas, cartridge applicator tampons cost \$125.00 for the initial stock,

Whereas, five model pad/tampon dispensers cost \$1,000.00 total,

Whereas, shipping is \$105.00,

Therefore, be it resolved, WSUSS allocates \$1,355.00 from the SAF to George Micalone and the Student Union for the cost of the Aunt Flow dispensers, initial stock of products, and shipping.

DISCUSSION ON RECOMMENDATION

- Treas. Rieken- this is in the bylaws instead of SAFC because it is club related, I am not dead set on any of this and I want this to be a discussion, *explains numbers and how the committee reached the as a conclusion*
- Sen. O'Connor- in a case with two separate clubs with two separate requests (referring to previous request) what would happen?
- Treas. Rieken- 15 per trip regardless
- Sen. O'Connor- travel request must be lesser option, will there be an opportunity to prove it?
- Treas. Rieken- depends on next treasurer
- Sen. Wright- are we worried that \$750 is only a round trip ticket? So some may get less depending on the distance
- Treas. Rieken- that is kind of the point, to have others be diligent about their funds and methods
- Chair Schiro- One thing when we were picking numbers, senate can always suspend the bylaws if needed
- Sen. Weber-

NEW AMMENDMENT (sec. By Sen. Palmerton)

Student Senate funding for travel will not exceed the following:

- No more than 15 people requesting funds for one trip (does not include other people going on the trip)
- No more than a maximum amount of \$750 \$500 per person for the entirety of the trip including all travel expenses (i.e. airfare, lodging, food, transportation, registration costs, ect.)
- WSUSS will not fund travel requests exceeding \$11,250 per request.

- Travel requests are up to the discretion of WSUSS for the total amount funded.
 - The request for transportation must be the lesser option between WSU Motor Pool rates, personal vehicle, or airfare.

DISCUSSION ON AMMENDMENT

- Sen. O'Connor- I agree, it was hard to cap the amount of people, but we should have a cap on the funds
- Sen. Wescott- I understand why we don't like the cap on people, but I'm thinking about seniors who get job offers from conferences, and yet they take more freshman
- Treas. Rieken- so unlimited people, could all get \$500
- Sen. Weber- that's why I lowered the amount, open to discussion, this year an issue has been bad comparisons for presentations
- Treas. Rieken- I'm not apposed to this, the third bullet point should be looked at for a maximum funding amount if we don't have a cap on people
- VP Hytry- can suspend the bylaws, we can do a hard maximum
- Sen. Palmerton- we don't have to keep this as the maximum, we could come up with a better number
- Sen. Carman- what did you base the 15 people on?
- Treas. Rieken- people presenting
- Sen. Carman- I don't like the thought about not having a certain amount of people
- Sen. O'Connor- As long as there is an amount per person and a total amount, I feel like there does not need to be a stated amount of people
- Treas. Rieken- if you do the math, it is 22.5 people, so it is important
- Sen. Eichele- It is good to set a base amount for general presentations, If in the rare instance that a larger group comes, we can suspend the bylaws, but it is good to set a precedent, not in favor in passing the amendment
- Sen. Houssain- would never like of limit number of people, I think this might deter students from coming and presenting
- Pres. M. Olson- this is a safehold to make sure all clubs and trips can get funded, allowing for
 more students to get funded, we will never know if we have more or less money at the end of the
 semesters, hopefully expand SAFC money for more students
- Sen. Minich- is there a way to track the students going to events that need funding, we would have a better idea of how to write this
- VP Hytry- money can be distributed however they would like to



Hermerding: club was not supportive of LGBTQIA+, mental health, health in general, we need to have a discussion about this for the students, if you don't know anything about chi alpha, do your research Sen. Wright- I have heard from folks about this who have had unfavorable interactions with them, if I hear information about them changing their tactics, I would be more considerable of reinstating them in a club

VP Hytry: they did not get kicked off of campus, legally there is no evidence of what has happened, we do not have the right to deny them, there are no facts backing them up, we have to treat them the same as

every other club, they did present to judicial, we examined their constitution, do not have the same advisor as previous, no reason to deny them

Sen. Magner- we did ask them all questions that many of you have, treated them like any other club, we have no other evidence, no reason we cannot reinstate them

Chair Carman- views and opinions are valid, nothing we can do to look at them any differently, we have to look at them in a neutral way, gave valid answers about what they want to do for clubs, cannot look at past due to lack of evidence

Chair Jones- is this something we can talk to constituents about?

Pres. M. Olson- not how we approach other club
