    - 1. Continue discussion of possible changes to Regulation 3-4 sign-off.

- a) Should a <u>program director</u> be allowed to sign-off instead of a 'Department Chair' for items such as notifications, new/revised courses, and new/revised programs?
- b) Should multiple department chairs be required to sign off on multidisciplinary program proposals?
- 2. Do A2C2 representatives have any more curricular concerns other than those stated in the attached "Regulation 3-4 Form Sign-off"
- 3. Joan Francioni discussed multi-disciplinary task force findings.
  The Interdisciplinary Studies Report presentation is available on the A2C2 website.
  - a) Joan's presentation reviewed the definition of Interdisciplinary Studies (IS), benefits of IS, existing WSU IS programs, existing support strategies and resources. Main findings:
    - i. No defined mechanism for oversight of interdisciplinary courses and/or curriculum
    - ii. No defined mechanism for fostering innovation involving multiple disciplines
    - iii. No defined mechanism for faculty in different disciplines to collaborate together in the development and delivery of new curriculum and/or courses
    - iv. Solutions needed to support developing programs and initiatives, foster new avenues for interdisciplinary innovation, work with (not in competition with) existing academic units. Specifically, strategies and infrastructure needed to support innovative program and component experimentation and development, collaboration across disciplinary programs, continued support for permanent programs, and definition of incentives and expected responsibilities for faculty supported in innovation programs.
    - v. Faculty Senate supported general concepts put forward by the Multidisciplinary Workgroup Task Force. Faculty Senate also supported continuing Task Force 2013-2014 academic year.
    - vi. A2C2 questions. Are there any other IS programs to add to the existing list of WSU IS programs? (none added)
    - vii. A2C2 comments to take back to Multidisciplinary Task Force.
      - i. Procedures should be in place to accommodate or change Reg 3-4 requirements for IS programs. Multiple entities should be involved due to the nature of these programs.
      - ii. IS program started, department "captures it", governed by that department, no longer interdisciplinary. Makes sense to push into a department because of the lack of structure currently because there is no other mechanism to keep IS programs to exist.
      - iii. Existing profile of another school with a successful IS program? Task Force looked at other programs not in

- MNSCU. This is where the "School of IS" came out of so it would not exist in a "college" and be owned by a "department."
- iv. Consider library support early in the process. Most of theme based programs have library liaison support, but not others (problem-based or stand-alone).
- v. To what degree is there a role of non-IFO entities? (ex. Inclusion and Diversity office)
- vi. Could current programs cede control to a hypothetical 'School of IS' outside of existing departments? How do we leverage talent at WSU and not harm education and work in departments?
- 4. Recommendation from PP&G, made at Faculty Senate 11/4/2013: Signatures for Changes in Curriculum

PP&G respectfully recommends to the WSUFA the following:

- a) Changes in courses or proposed new courses housed in departments require the signature of that department's chair,
- b) Changes in existing courses or proposed new courses specifically housed solely in a program require the signature of that program's director, and
- c) Changes in the curriculum of a program that affect other departments or programs require evidence from those areas that they can accommodate the proposed changes.
- 5. A2C2 reps should take recommendations from PP&G back to departments for discussion and feedback.

# Regulation 3-4 Form Sign-off

### Considerations:

- Both program directors and department chairs are from the faculty ranks.
- Program director is appointed by a dean, represents the program? No term limit.
- Department chair is elected and represents department. Chair has a 9 year term limit.
- Example programs-
  - WAGS, a minor with courses from COLA, COE, CONHS and several departments. It has a 12 member faculty advisory committee, and a subcommittee to review 'WAGS' curricular proposals.
  - o HLA, a major with courses from all 5 colleges, and Bemidji State University. Not known if there is a WSUFA faculty advisory committee.
  - o CAST, a minor, with courses from CAST, in CONHS, but not in a department. It has a 7 member faculty advisory committee.
  - o Sustainability, a minor with courses from COSE, COLA, CONHS. Not known if there is a WSUFA faculty advisory committee.
  - o PSM, a graduate program involving COSE, COB. It has a 12 member implementation task force.
  - o Individualized Studies, a major with 48 semester hours of upper-division courses. Has a 7 member faculty OCED faculty oversight committee. OCED has recently (see Senate meeting 10/21/13) been working to get a faculty liaison position.

### Past/Current practices:

CAST-some new course paperwork has been signed by faculty who were not Department Chairs.

At least one CAST notification was signed by Sociology Department Chair.

WAGS-faculty sign-off on Department Chair line.

Sustainability -affected department chairs sign when their department is affected (MKT, GS).

PSM-Courses with prefixes that belong to a department are signed by that department chair.

Courses with PSM designation, or paperwork affecting program structure are signed by all department chairs involved. This requires PSM participants to work hard to develop courses and a program that the participating departments agree with.

COB admission requirements during the AACSB accreditation process prompted a change to the A2C2 charge that was made for college-wide curricular matters. Once the college-wide subcommittee consisting of A2C2 representatives approved the curricular matter, the paperwork was submitted by the individual departments. This could serve as a model for multi-disciplinary programs such as HLA that span universities, colleges and departments. Or Faculty Senate could create an HLA Faculty Advisory Committee made up of departments that provide courses for the HLA program. See 10/6/2008 Faculty Senate minutes for more details.

#### Possible motions:

- 1. Revise Regulation 3-4 "Notification Forms" and "New and Revised Course and Program Proposal Signature Sheet" approval lines replacing words "Department" with "Department/Program" and "Department Chair" with "Department Chair(s)/Program Director".
- 2. Any curricular proposal developed by an entity other than a department will be accepted for consideration by A2C2 provided said entity has had the curricular proposal reviewed and approved either by a faculty advisory or faculty oversight committee recognized and approved by the WSU Faculty Association, or by the chairs of all the affected departments.
