Social, political and economic issues in Latin American will be explored through Latin American and Latino/a literature. Students will gain an understanding of the role of Latin American women and men in these processes through readings, discussions, and films. They will be evaluated on based on discussion of readings, class participation, and 4 Exams.

Students will grasp theoretical underpinnings and style of Latin American literature in translation and be able to articulate those orally and in written form. In addition, they will be able to make cross-cultural comparisons to examples in their own lives.

Provide a rationale for the new course. The rationale should include the following items.

1. A statement of the major focus of the course.

The intent of GSWL 234 is to impart knowledge and understanding of Latin American culture through a critical analysis of some of its prominent literature. By discerning the social processes within the texts, students will become aware of gender and power relations within specific geo-cultural circumstances, and thus be cognizant of the vast diversity within Latin America, and be better able to grasp and understand global perspectives different from their own. It is expected that this course will have 30 students, which will promote discussions and presentations. Acclaimed novels and short stories in translation will be the texts utilized, and complemented with appropriate films when possible.

2. A statement of how this course will contribute to the departmental curriculum.

GSWL 234 will contribute to department curriculum by adding humanistic perspectives to Latin American Studies, as well as deepening student appreciation of different literary and aesthetic styles.

- 3. A statement of why this course is to be offered at this level (i.e. 100-, 200-, 300-, 400-, or 500-level)

 This course is offered at 200 level to attract a broad student body with little specialization in Global Studies.

 This course will be cross-listed with WAGS 234 and attract more students to encourage cross-disciplinary communication and discussion about citizenship and global feminisms.
